- Global X will report the aggregate amount of contributions made. Where monies are donated to a registered charity, Global X may be entitled to a donation receipt issued by the charity. Any amounts donated are not, in any way, an additional expense to the funds.

As of 11<sup>th</sup> October 2022, the organisation we are partnering with is Carbon Neutral, specifically their Plant-a-Tree Program. Carbon Neutral has over 20 years of experience creating innovative large-scale reforestation projects that restore landscapes, preserve biodiversity and sequester large amounts of atmospheric carbon.

Carbon Neutral's Plant-a-Tree programme forms an integral part of the award-winning Yarra Yarra Biodiversity Corridor in Western Australia. This ambitious broadscale reforestation project is helping to reconnect small patches of remnant vegetation to create a 200km green corridor, and in doing so, is enhancing and restoring the precious flora and fauna biodiversity of this fragile landscape.
