# Target Market Determination

## TARGET MARKET SUMMARY

This product is intended for use as a minor or satellite allocation for a consumer who is seeking income distribution or capital preservation and has a very high to extremely high risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a 2 year investment timeframe and needs daily access to capital.

The Fund is an exchange traded fund (ETF) and is generally only available to consumers through the ASX via a broker.

## INVESTMENT PRODUCTS & DIVERSIFICATION

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (for example, with an intended product use of minor allocation). In such circumstances, the product should be assessed against the consumer's attributes for the relevant portion of the portfolio, rather than the consumer's portfolio as a whole. For example, a consumer may seek to construct a balanced or moderate diversified portfolio with a minor allocation to growth assets. Capital Growth		<p>The Fund aims to provide consumers with a return that tracks the performance of the Cboe S&amp;P 500 BuyWrite Index (the "Index") before fees and expenses.</p> <p>The Fund consists of an underlying fund that holds a portfolio of exchange traded securities comprising the S&amp;P 500 Index (the "Benchmark Index"), and systematically writing exchange traded call options over 100% the Benchmark Index.</p>
Capital Preservation		<p>By virtue of the nature of a covered call strategy, an investor is sacrificing upside exposure to the Benchmark Index for the regular receipt of income generated by the sale of call options. The covered call strategy also acts as a partial hedge against a decline in securities comprised in the Benchmark Index. Therefore, the Fund aims to offer a regular source of distribution income and may be considered to offer a consistent and reliable source of income. The Fund will, therefore, likely be suitable for consumers who are seeking income distribution.</p> <p>The Fund is not considered to offer capital growth, as by writing call options over the Benchmark Index the Fund potential forgoes capital gains resulting from the price appreciation of the securities of the Benchmark Index. Consumers seeking capital growth over the short to long term are therefore not consider to be within the target market.</p>
Income Distribution		<p>The Fund may potentially also be suitable for consumers who are seeking capital preservation as a minor or satellite allocation within a broader diversified portfolio. Income generated from the written call maybe considered as a partial buffer to offset negative market performance.</p> <p>The Fund is not designed to provide tax effective income for a particular class of consumer. Therefore, the Fund is not likely to meet the objectives of consumers who have a primary objective of tax effective income distribution.</p>

Minimum Investment Timeframe	2 Years	As noted above, covered call strategies typically sacrifice upside exposure to a security or securities for the regular receipt of income generated by the sale of call options, and therefore offer potential lower capital growth over the medium to long term but exhibit consistent income distributions. Consumers with a minimum 2-year investment timeframe with a high to extremely high risk / return profile potentially fall within the target market.

Instructions to issuers: Issuers should undertake a comprehensive risk assessment for each product. This TMD uses the Standard Risk Measure (SRM) to estimate the likely number of negative annual returns for this product over a 20 year period, using the guidance and methodology outlined in the Standard Risk Measure Guidance Paper For Trustees (note the bands in the SRM guidance differ from the bands used in this TMD). However, SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return (including under conditions of market stress) or that a positive return could still be less than a consumer requires to meet their investment objectives/needs. The SRM methodology may be supplemented by other risk factors. ### CONSUMER'S NEED TO ACCESS CAPITAL

This consumer attribute addresses the likely period of time between the making of a request for redemption/withdrawal (or access to investment proceeds more generally) and the receipt of proceeds from this request under ordinary circumstances. Issuers should consider both the frequency for accepting the request and the length of time to accept, process and distribute the proceeds of such a request. To the extent that the liquidity of the underlying investments or possible liquidity constraints (e.g. ability to stagger or delay redemptions) could impact this, this is to be taken into consideration in aligning the product to the consumer's need to access capital. Where a product is held on investment platforms, distributors also need to factor in the length of time platforms take to process requests for redemption for underlying investments. Where access to investment proceeds from the product is likely to occur through a secondary market, the liquidity of the market for the product should be considered.



## DISTRIBUTOR REPORTING

### Significant Dealings

Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is 'significant' and distributors have discretion to apply its ordinary meaning.

The issuer will rely on notifications of significant dealings to monitor and review the product, this TMD, and its distribution strategy, and to meet its own obligation to report significant dealings to ASIC.

Dealings outside this TMD may be significant because:

- they represent a material proportion of the overall distribution conduct carried out by the distributor in relation to the product, or
- they constitute an individual transaction which has resulted in, or will or is likely to result in, significant detriment to the consumer (or class of consumer).

In each case, the distributor should have regard to:

- the nature and risk profile of the product (which may be indicated by the product's risk rating or withdrawal timeframes),
- the actual or potential harm to a consumer (which may be indicated by the value of the consumer's investment, their intended product use or their ability to bear loss), and
- the nature and extent of the inconsistency of distribution with the TMD (which may be indicated by the number of red and/or amber ratings attributed to the consumer).

Objectively, a distributor may consider a dealing (or group of dealings) outside the TMD to be significant if:

- it constitutes more than half of the distributor's total retail product distribution conduct in relation to the product over the quarter,
- the consumer's intended product use is solution/standalone,
- the consumer's intended product use is core component or higher and the consumer's risk/return profile is low, or
- the relevant product has a green rating for consumers seeking extremely high risk/return.
