INDEX DESCRIPTION

The S&P 500 Low Volatility High Dividend Index serves as a benchmark for income seeking equity investors. The index is designed to provide exposure to 50 high yielding companies from the S&P 500, while meeting diversification, volatility and tradeability requirements.

At each semi-annual rebalance, the index selects the 75 highest yielding eligible shares from the S&P 500. From this selection, the 50 least volatile shares are included in the index.

Index constituents are weighted in proportion to their dividend yields.
